## 4. First Aid Measures

---

<b>Inhalation</b>	Vapour inhalation under ambient conditions is normally not a problem. If overcome by vapour from hot product, immediately remove from source of exposure. Move the exposed person to fresh air at once. For breathing difficulties, oxygen could be necessary. Seek medical attention if any discomfort continues.

<b>Protective Measures</b>	Put on appropriate personal protective equipment.
<b>Occupational Hygiene</b>	Smoking should be prohibited in areas where this material is handled or stored. Wash thoroughly after handling, remove contaminated clothing and protective equipment before entering eating areas.
<b>Safe Storage</b>	Store in original container, protected from direct sunlight in a dry, cool and well ventilated area away from incompatible materials. Keep container tightly closed and sealed until ready for use. Carefully reseal opened containers and keep them upright to prevent leakage.
